- Dogs may be dropped off by car, or by walking to our location 8040
  Georgia Avenue Suite 100, Silver Spring MD 20910. A drop off Concierge
  stand is located off Blair Mill Road/Georgia Avenue. You must schedule a
  drop off time prior to appointment. There is no charge for this service. Pick
  up by car Concierge stand is located off of Blair Mill Way.
- 2. Our Dog Concierge service to pick up or drop off at your home within the 20910 designated area is \$ 20.00 per trip. A trip is considered one way.

  Must be scheduled at the time of appointment.
- 3. You may drop off by car at Dog Concierge stand and reserve a Dog Concierge to drop your dog off at your home. Or drop off in person, and request a Dog Concierge drop off when dog is finished with appointment.

Payment is required up front prior to grooming appointment. Credit cards, Visa, Mastercard, Amex and Discovery. Cash is also accepted at the location only. Personal Checks are not accepted. Dog Concierge tips may be accepted by cash or credit card.					
Owner understands this agreement is for walking only and will not include training.					
All dogs are required to be fully vaccinated and be licensed by their city, records must be up to date prior to service.					
The owner is responsible for any cost/payments due to bites. If a bite occurs, GROOM! SALON INC. DOG CONCIERGES is responsible for reporting it.					
GROOM! is authorized to seek any medical care if deemed necessary with releasee from all liabilities related to transportation, treatment and expenses, and is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. Owner agrees to reimburse GROOM! SALON INC. for any expenses incurred attending to this need.					
In the event of personal emergencies or illnesses of Dog Concierge, GROOM! SALON INC. will notify owner as promptly as possible and fees for missed walk will be reimbursed.					
In the best interest of both your dog and GROOM! DOG CONCIERGE TEAM, walks will not be occurring if the temperature is below 25F or above 95F o extremely high winds or heavy rain in the event of inclement weather.					
Cancellation Policy-A minimum of 24 hours cancellation notice is required. Cancellations with less than 24 hour notice may be charged at full rate. If owner wishes not to continue to use the service, we ask owner to make these request in writing.

## Releasee of Liability

I do hereby waive and release GROOM! SALON INC. from any and all liabilities of any nature for the actions of myself, my dog, or any other person who accompanies me, or holds a key to my home; except those arising from negligence or willful misconduct on the part of GROOM! SALON INC. DOG CONCIERGE. GROOM! SALON INC. agrees to provide all services in kind, humane, reliable and trustworthy manner. Owner agrees to notify GROOM! SALON INC. of any concerns within 24 hours of their return. In case of an emergency, inclement weather or a natural disaster I authorize GROOM! SALON INC. to use their reasonable judgment for the protection and wellbeing of my dog.

I understand GROOM! SALON INC. can terminate this contract/agreement if my dog becomes a threat to the safety or health of GROOM! SALON INC. community or Dog Concierge due to aggressive behaviors or tendencies. I acknowledge I am responsible for medical expenses and damages resulting from an injury to GROOM! SALON INC. team, or other person or animal caused by my pet(s). GROOM! SALON INC. reserve the right to refuse service to any client, at any time, for any reason.

I attest that all of the above information is true to the best of my knowledge. If anything changes from what is listed, I will inform GROOM! SALON INC. before next service is scheduled. This signed document gives GROOM! SALON INC. to enter the above listed address as agreed scheduled time to perform the necessary dog concierge service. I authorized this contract to be valid approval for services so as to permit GROOM! SALON INC. to enter my home without additional signed contracts or written authorizations.
